- (3) Whether the event(s) are likely to unreasonably interfere with the activities of people living or working in the vicinity; cause injury to property; or create an unreasonable disturbance.

Applicant should provide sufficient detail and information to enable the Board of Trustees to make its determination. The Applicant may attach additional pages and documentation as it deems necessary.

By submitting an Outdoor Music Entertainment Permit application an applicant represents that it has read, is familiar with the requirements of, and will comply with the Village's "Outdoor Music Entertainment" and "Noise Control & Abatement" local laws.

**Notice:** Any changes to the information provided in this application must be reported to the Village Clerk within 10 business days or before the next event for which a license has been issued, whichever occurs first.
